

"Connected" CONTEST
OFFICIAL RULES AND REGULATIONS

1. How to Enter.

No purchase necessary. To enter the Connected contest (the "**Contest**"), fully complete and submit the online survey located at <https://xplore.typeform.com/connected> after 10 AM EST on December 1, 2022, but no later than 10 PM EST on December 18, 2022 (the "**Contest Closing Time**"). In addition to completion of the survey, entries must include a choice of one Prize Package listed below. Limit of one entry per person permitted during the Contest. All entries that are incomplete, illegible, damaged, irregular, have been submitted through illicit means including use of any automated system to participate, or do not conform to or satisfy any condition of these official rules and regulations ("**Rules**") may be disqualified. All entries submitted become the property of the Sponsor and will not be returned.

2. Eligibility.

The Contest is open to legal residents of Canada (excluding Nunavut, Yukon, the Northwest Territories and Quebec) who have reached the age of majority in their province of residence at the time of entry. Employees, officers, and directors (including immediate family members and members of the same household) of Xplore Inc. (the "**Sponsor**") its affiliates, distributors, dealers, marketing representatives, printers, advertising or promotional agencies, or any other organization associated with the Contest are not eligible to participate.

3. Prizes.

There are three prize packages (each a "**Prize Package**" and collectively, the "**Prize Packages**") available to be won as follows: 1) Prize Package One consisting of a gaming computer and monitor, with an approximate retail value of \$2,000CAD; 2) Prize Package Two consisting of a tablet + magnetic pencil + keyboard, with an approximate retail value of \$1,400; 3) Prize Package three consisting of a Smart TV + Gaming Console, with an approximate retail value of \$1,500CAD. The Sponsor reserves the right to substitute any of the Prize Packages in whole or in part for a prize of equal or greater value in the event that any component of a Prize Package is unavailable for any reason. The Prize Packages must be accepted as awarded and no substitutions, except as identified above, will be made. The Prize Packages may not be sold, transferred or assigned and are not convertible to cash.

4. The Prize Draws.

On December 19, 2022 at approximately 2PM EST, three random draws shall take place as follows: (i) a random draw will take place to select a potential winner of Prize Package One from among all eligible entries received who selected Prize Package One upon entry. The first entry drawn will be eligible to win Prize Package One. The odds of winning

Prize Package One will depend on the total number of entries received up to the Closing Closing Time who selected Prize Package One upon entry; (ii) a random draw will take place to select a potential winner of Prize Package Two from among all eligible entries received who selected Prize Package Two upon entry. The first entry drawn will be eligible to win Prize Package Two. The odds of winning Prize Package Two will depend on the total number of entries received up to the Closing Closing Time who selected Prize Package Two upon entry; and (iii) a random draw will take place to select a potential winner of Prize Package Three from among all eligible entries received who selected Prize Package Three upon entry. The first entry drawn will be eligible to win Prize Package Three. The odds of winning Prize Package Three will depend on the total number of entries received up to the Closing Closing Time who selected Prize Package Three upon entry.

The Sponsor will attempt to notify each selected entrant within 7 days of the draw. In order to be declared a winner, each selected entrant must correctly answer, unaided, a time-limited skill-testing question and, within the time specified by the Sponsor, complete and return to the Sponsor a contest eligibility and liability/publicity release confirming compliance with these Rules, releasing the Sponsor and its directors, officers and agents from all liability and, except where prohibited by law, permitting the Sponsor to publish, reproduce and/or use the selected entrant's name, address (city and province), photography or other likeness, and testimonial, without compensation, worldwide and in perpetuity, in any and all forms of media now known or hereafter devised, including the Internet, in any publicity carried out by the Sponsor. Selected entrant must also provide proof of identity upon request. In the event that a selected entrant is not eligible for any reason, has not correctly answered the skill-testing question and returned the release form, or cannot be contacted within 7 days of the draw, such entrant shall be disqualified and the Sponsor shall have the right to select another entrant and the Sponsor shall be released and discharged from any liability or responsibility in this regard. No correspondence will be made except with the selected entrants.

5. General.

By entering the Contest, entrants agree to abide by these Rules, and further agree that the decisions of the Sponsor are final. The Sponsor reserves the right, , at any time without prior notice to suspend, modify or terminate the Contest for any reason. The Sponsor reserves the right in its sole discretion to disqualify any individual they find to be tampering or disrupting the online entry process or the operation of the Contest or acting in violation of these Rules. The Sponsor does not assume any responsibility for any lost, delayed, incorrect or incomplete entry information howsoever caused. The Sponsor is not liable for injuries, death, damages or losses of any kind resulting from participation in the Contest or acceptance or use of the Prize Package. In the event of a dispute, entries submitted online will be deemed to have been made by the authorized account holder of the email address submitted at time of entry. "Authorized account

holder" means the natural person who is assigned to an email address by an Internet access provider, online service provider or other organization (e.g., business, educational, institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

6. Privacy and Personal Information.

By entering the Contest each entrant consents to the collection, use and disclosure of his/her personal information (information that identifies an entrant as an individual, such as home telephone number, age and home address) by the Sponsor for the purposes of implementing, administering and fulfilling the Contest. 7. Publicity of Winners Names.

The name of the Prize winner may be posted online or otherwise beginning on the first business day after the winner has been contacted and has returned a fully completed contest eligibility and liability/publicity release to the Sponsor as set out above.

8. Subject to Applicable Laws.

This Contest is governed by the laws of Canada, is subject to all applicable federal, provincial and municipal laws and regulations and is void where prohibited
